1. Platform Purpose

Nunuz Hub is a platform connecting students with tutoring services.

- **Lwandiso Nunu**, the founder, owner, and director of Nunuz Hub, provides personal tutoring services which are clearly indicated on the platform.
 - Any other tutors listed in the future are independent service providers.

2. Independent Contractor

- Tutors other than Lwandiso Nunu operate independently, set their own rates, manage their own scheduling, and are responsible for their own tax obligations.
 - Nunuz Hub does **not control how independent tutors deliver their services.**

3. Eligibility & Verification

- Tutors must provide proof of skill or competence before listing.
 - For **academic subjects or modules**, the Tutor must have obtained at least a **65% pass mark** in the subject or module they wish to tutor or instruct.
 - Nunuz Hub may reject or remove tutors who provide **false or misleading information.**

4. Listing Fees & Renewal Policy

1. First 5 tutors listed on the platform:

- Pay a **once-off R150 listing fee.**
- Enjoy **lifetime listing** with **no renewal required.**

2. All other tutors:

- Pay a **once-off R150 initial listing fee.**
- Must pay a **yearly renewal fee of R120** to remain listed on the platform.
- **Renewal is required by 31 December each year**, regardless of when the tutor was initially listed.

- Failure to renew by 31 December will result in **profile deactivation** until payment is made.

Note: This section does not apply to Lwandiso Nunu's personal tutoring services, which are automatically included.

5. Reviews & Quality Control

- Nunuz Hub may collect student feedback manually (Version 1) or automatically in future versions.
 - Tutors may be removed at Nunuz Hub's discretion if repeated or serious complaints arise.
 - No refunds will be issued if the tutor is removed.

6. Use of Images & Content

- Tutors grant Nunuz Hub permission to display:
 - Profile images
 - Biographical information
 - Academic results or skill proof
 - Verified student reviews
- Tutors confirm all submitted content is **accurate**.

Note: Lwandiso Nunu's images and content are automatically displayed as part of the platform.

- Listing on Nunuz Hub **does not guarantee students, bookings, or income.**
 - Exposure on the platform is for marketing purposes only.

- Nunuz Hub may modify features, listings, or review systems at any time.
 - Lifetime listing applies to profile visibility (first 5 tutors only), not feature access.

9. Limitation of Liability

- Nunuz Hub is not responsible for:

 - Academic outcomes
 - Lesson delivery issues
